TOPIC: "The Clank of Arms Be Heard No More"

SPEAKER: Frederick and Carol Miller

James Augustus Miller was a 32 year-old farmer with a wife and 5 year old son when he answered President Abraham Lincoln's second call for volunteers to fight to save the Union. The year was 1862. He signed up at Herkimer, New York and was assigned to Company C, 152nd Regiment of New York State Volunteers. This regiment served in many key battles of the Civil War. Many of his "adventures are described in 40 of his 120 letters home to his wife, Caroline and their young son Merritt James Miller. The letters are in safe keeping of Frederick Miller of Glen Ellyn, one of James' great grandsons.

During the siege of Petersburg, Virginia and the Battle of Weldon Station, the 152nd Regiment was flanked by surprise. James and five of his hometown friends were captured on June 22, 1864, briefly imprisoned in Richmond, then sent by railroad to a new Confederate prison camp in Andersonville, Georgia. His letters home stopped. After four months of what has been described as horrible living conditions, a lack of fresh water, and very little food, James died at age 34, on October 26, 1864. His grave is No.11516 in the cemetery at the Andersonville National Historic Site.

On Friday, January 1, 1864, ten months before he died in captivity, James wrote these words looking for a better time ahead:

"And today I think the prospects of the future look brighter as regards our country, and rebellion will soon be played out. My earnest prayer is that it may, and **the clank of arms be heard no more**, North or South, but become as one, inseparable, and live as in the days that are passed and gone."

Frederick and Carol Miller will present the program about his great-grandfather's activities during the Civil War as told through his letters written home.

MARCH MONTHLY MEETING REPORT by Art Foley

Last meeting, Mr. Charles Banks provided an overview of the Battle of Monocacy. Describing the strategic situation facing the Army of Northern Virginia and a desire to protect sources of food and material supply in the Shenandoah Valley, Robert E. Lee dispatched Jubal Early with elements of the II Corps in mid- 1864.

Early retook the offensive in the valley, driving David Hunter's command into safety at Harper's Ferry, thus obtaining a clear path to Maryland and the Capital. Driving his 10,000 troops forward in torrid June weather, Early had overly ambitious plans to disrupt the Baltimore & Philadelphia Railroad, destroy the C & O canal, raid northern towns, release Confederate POWs at Point Lookout, and threaten the Capital. Screened by cavalry on his drive north, Early's men crossed the Potomac on July 8th. Union officials, heretofore in the dark about the rebel force's objective, were frantically looking for information and gathering troops to meet the emergency.

After Confederate raids on Hagerstown, Middletown, and Frederick, Maryland, the path of the rebel force became clear. Union Major General Lew Wallace, commander of the Washington defenses, took the initiative, channeling over 3200 troops to Monocacy Junction. At the last minute, units of the VI Corps, commanded by General James Ricketts, double timed their way into the junction while Early's cavalry was probing Federal defenses. Holding the bridge passages across the Monocacy River, Wallace had forces dug in and manning blockhouses. To his south, the 8th Illinois Cavalry skirmished with Confederate probes at 8:30 that morning. Fighting raged back and forth over the farmland south of the Georgetown Pike for most of the day, ultimately pushing the Union lines back to the Pike. By 4:30, Wallace was forced to order the burning of the wood bridge and to call a general retreat after Rickett's men are flanked on their right by General John Gordon's units. The fleeing Union men head north to the Baltimore Pike and make good their escape. Stung by the solid Union defense of the junction, Early's troops pursued for only two miles and then returned to the field. The Confederates won the battle but lost the race to the Capital. Wallace's stubborn defense gave the Federals a full day on the enemy, enough time to man the defenses surrounding the city. Early was blocked and retreat became a necessity. This would be the high mark of the Confederate offensive. Grant was convinced to eliminate the threat in the Valley. He would send a force commanded by General Phil Sheridan which would remove the supply flow and the majority of the Confederate units from the area by late fall of 1864.
